I agree my dog is on a regular flea, worm and tick prevention treatment. Should fleas be found on my dog, I authorise Zinja Pty Ltd (trading as ScoobyDooz) to administer a Capstar tablet to my dog at a cost charged to me. I see no reason as to why my dog cannot have Capstar. Capstar is a tablet that kills fleas on the dog within 20 minutes. All dogs being administered Capstar are monitored for any adverse reaction.

I understand that Scoobydooz closes at 7.00pm sharp, and should I be late, the following charges apply:

WAIVER AND RELEASE In consideration of being permitted to have my dog(s) attend ScoobyDooz:

DAYCARE:

I agree that when my pet attends daycare that I have read and understood the following risks involved.

Whilst I understand that all care and effort will be taken to prevent injuries and whilst injuries rarely occur, injuries that may occur throughout the daycare day could be, but are not limited to:

- Minor and major dog scratches
- Minor and major dog bites
- Broken limbs
- Torn ligaments
- Foot infections and sore pads
- Worn down nails
- Muscle sprains
- Canine illnesses such as canine cough

Whilst it is understood that the daycare staff will exercise caution and their duty of care during the daycare day, and that careful assessments are made on every dog that attends daycare, I am aware that due to the nature of the environment, my pet may be injured and that no amount of supervision, sanitation or cleanliness could prevent an airborne illness such as canine cough from spreading. In the unlikely event that an undesirable incident should occur, I understand my pet may require veterinary attention to protect the animals' welfare.

GROOMING:

I am aware that should my pet be presented for grooming in a "matted", "oily" or otherwise anomalous condition and/or my pet is excitable or aggressive during the grooming process that I have read and understand the following:

1. ScoobyDooz will clip my pet as is necessary (in their opinion) to remove the matted coat.
2. That Scoobydooz has a no de-matt policy and therefore will not de-matt my dog.
3. Often a coat can contain individual mats specific to areas of the body which cannot always be seen upon first inspection.
4. Muzzle my dog or use grooming restraints should the dog be excitable or aggressive.

Whilst it is understood that the groomer will exercise caution and their duty of care during the above mentioned grooming process, I am aware that due to its condition or temperament, my pet may be cut or grazed. In the unlikely event that either or both of these undesirable incidents should occur, my pet may require veterinary attention following the grooming procedure to protect the animals' welfare.

I have read the statements above and hereby give ScooyDooz my consent and authorisation to seek veterinary advice and/or attention at their discretion in my absence and that I do not and will not hold any of the staff or business responsible for the incident or deem them liable for the veterinary costs that may be incurred. I understand I will be responsible for all veterinary cost to do with my dog in the event of an accident, injury or illness.
